SAND HILL ADVISORY COMMITTEE March 20, 2006

<u>Attendance</u>: Chairman Todahl called the March 20, 2006 meeting of the Sand Hill Advisory Committee (SHAC) to order at 8 a.m. at Eats N' Antiques in Fertile, MN. Other advisory members present were Allan Stromstad, Gerald Jacobson, Bruce Stromstad, and Stephen Taylor. Others in attendance were Daniel Wilkens-Administrator, April Swenby – Administrative Assistant, & Roger Hanson – Sand Hill River Watershed District Chairman.

<u>Annual Reorganization:</u> The Annual Organization of the SHAC was conducted. Chairman Todahl turned the meeting over to Daniel Wilkens who asked for nominations for Chairman of the SHAC. Allan Stromstad nominated Jim Todahl for Chairman. Nominations were called for three times by Daniel Wilkens. No further nominations were made. <u>Motion</u> to cease nominations and have the Secretary cast a unanimous ballot for Jim Todahl for Chairman by Bruce Stromstad, <u>Seconded</u> by Allen Stromstad, <u>Carried</u>.
