IT IS HEREBY RESOLVED, That an ad valorum tax be levied against all taxable property with in the District; in the amount of 3-0 mils for the three funds of the District, collectible with the taxes payable in the year of 1987.

IT IS FURTHER RESOLVED, That said total amount shall be divided by the District as follows: 1.0 mill for the Administrative Fund of the Sand Hill River Watershed District and 2.0 mills for the two Lower Red River Funds.

IT IS FURTHER RESOLVED, That the County Cuditors of the Counties of Mahnomen, Norman and Polk shall levy 3.0 mills, the proceeds of which shall be forwarded to the Treasurer of the Sand Hill River Watershed District.
