It IT IS FURTHER RESOLVED, that said total amount shall be divided by the District as follows: One (1.0) mil for the Administrative Fund of the Sand Hill River Watershed District and two (2.0) mills for the Lower Red River Funds,

IT IS FURTHER RESOLVED, That the County Auditors of the Counties Mahnomen, Norman and Polk shall levy three (3.0) mills, the proceeds of which shall be forwarded to the Treasurer of the Sand Hill River Watershed District.
