Gullekson checked several places in Fertile and Crookston regarding insulation in the ceiling. The best value was 18" of fiber glass insulation, with R-factor of 50, installed for \$1225.00. Gullekson, Wilkens, Hanson and Woodbury went to St.Paul and met with the Pollution Control Agency. We need a year long study of the quality of water going into the dam and water going out. AGNPS would not be practical on a large watershed area.
- 7. Motion by Larson that we accept Bob Thorson's maximum labor bid of \$750.00 for refinishing the woodwork with two coats of varnish and putting on two coats of paint on the walls. Motion seconded by Wilkens. Motion passed unanimously. Work will begin Monday July 17, 1989.
- 8. Water Quality Study-Board will ask a local person to take samples of water. Twin City Laboratory can do the testing. Samples cost \$9.00 to \$21.00 per sample. Probable cost \$25,000. There was a letter from John B. Erdmann of Wenck Associates, Inc. regarding QUAL2E Modeling.
- 9. There was some discussion regarding the flowing well and the quality of the water. It is extremely high in Sulfur and Iron.

- 10. The Fertile Future Focus Committee has invited the Lower Red River Water Management Board to hold their regular monthly meeting at the Fertile Community Center on Wednesday July 19, 1989. The Board will be served a dinner and the Board will be given a tour of the Sand Hill River Watershed District Building.
- 11. Motion by Wilkens that the Sand Hill River Watershed District match the City of Fertile money of \$300.00 to give to Fertile Future Focus. Motion seconded by Larson. Motion passed unanimously.
- 11. Motion by Larson to pay current vouchers. Motion seconded by Hanson. Motion passed unanimously.
