Robert Murcha said he thought that the Polk County Highway would go with one culvert if Sletton Dam and road is built. County Highway Department may give money they have allocated for culverts toward dam construction.

Robert Muscha indicated that Highway # 59 project would be more worthwhile, but funding would be difficult at present. Carsten Zahl reported that 21 of 26 land owners have signed and a couple more possible will sign. Board authorized Houston Engineering to determine cost of Highway # 59 project and approach Lower Red River for funding
